

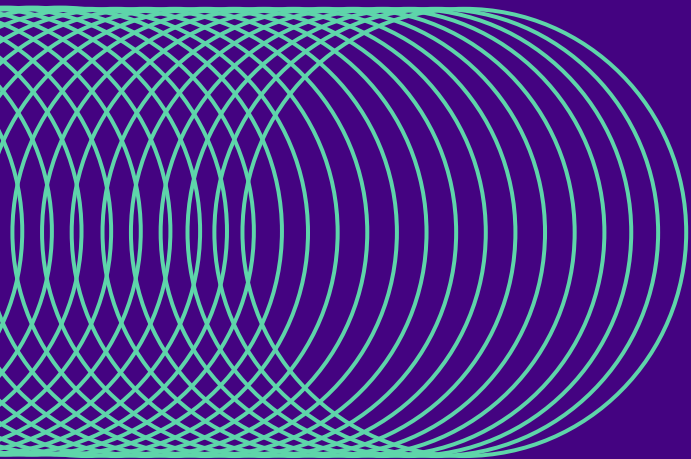

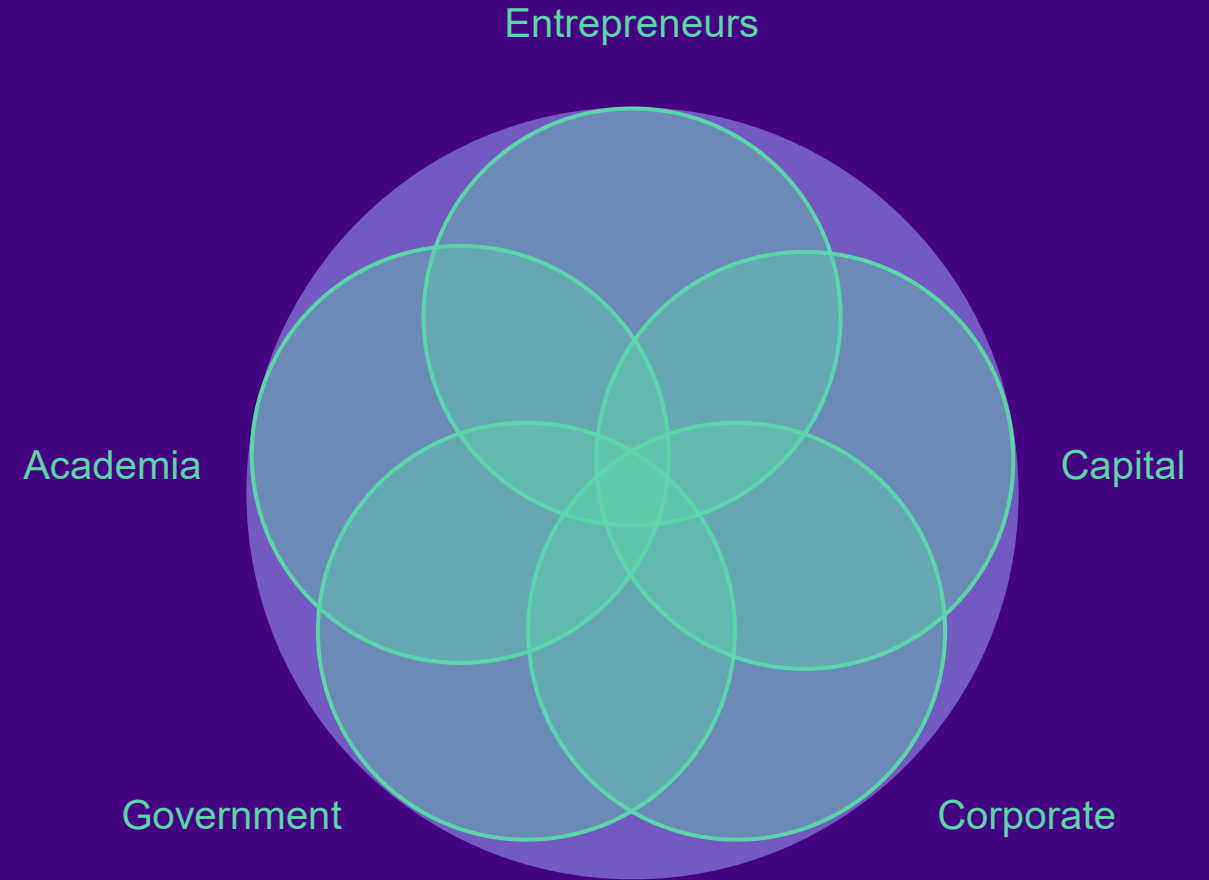

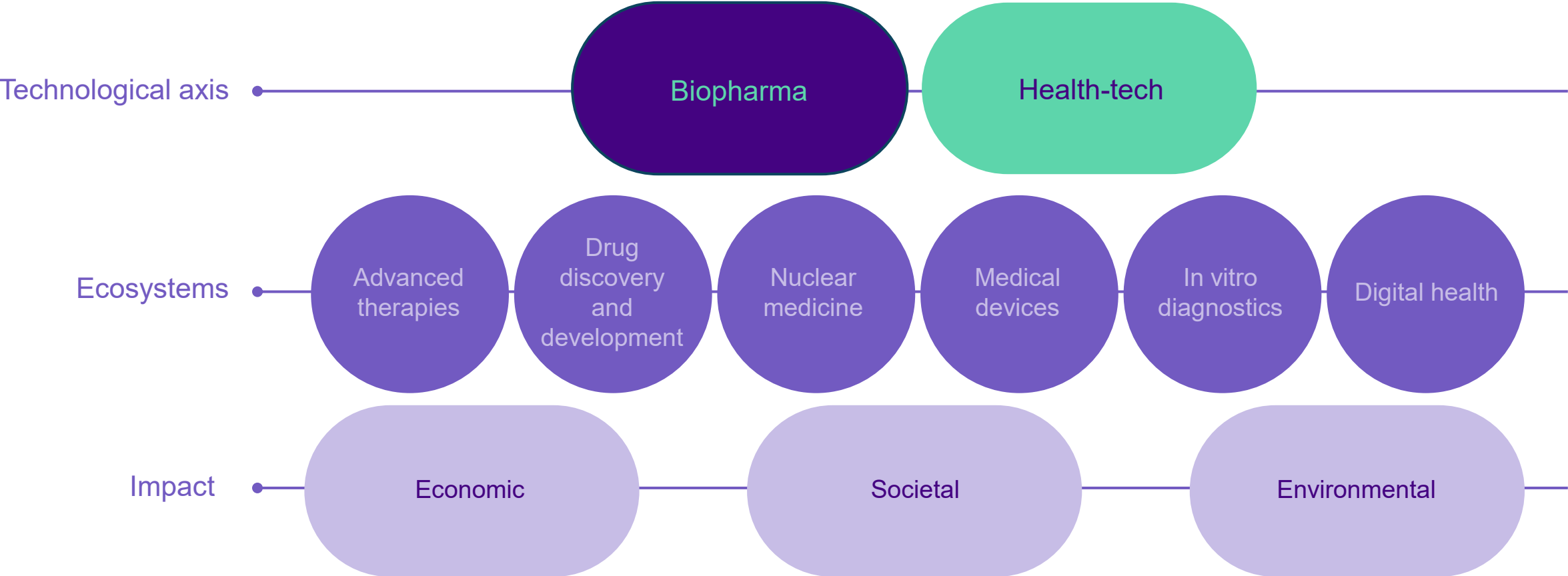

We develop actionable plans to strengthen the health-tech and biopharma sectors by identifying challenges, opportunities and priorities for growth.

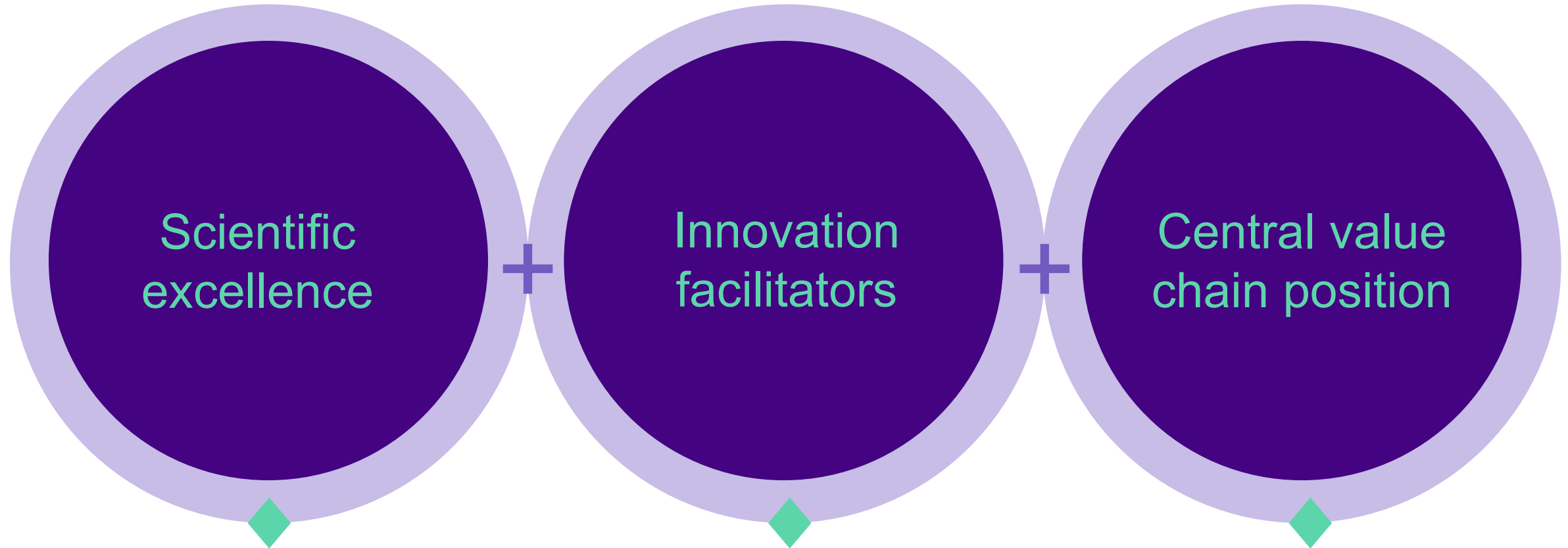

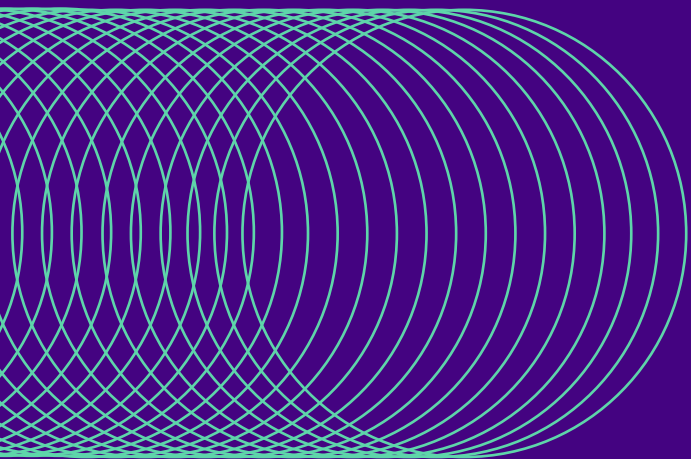

BioWin leverages its innovation expertise and network to provide strategic guidance, support and advice regarding funding opportunities available to help businesses continue to grow.

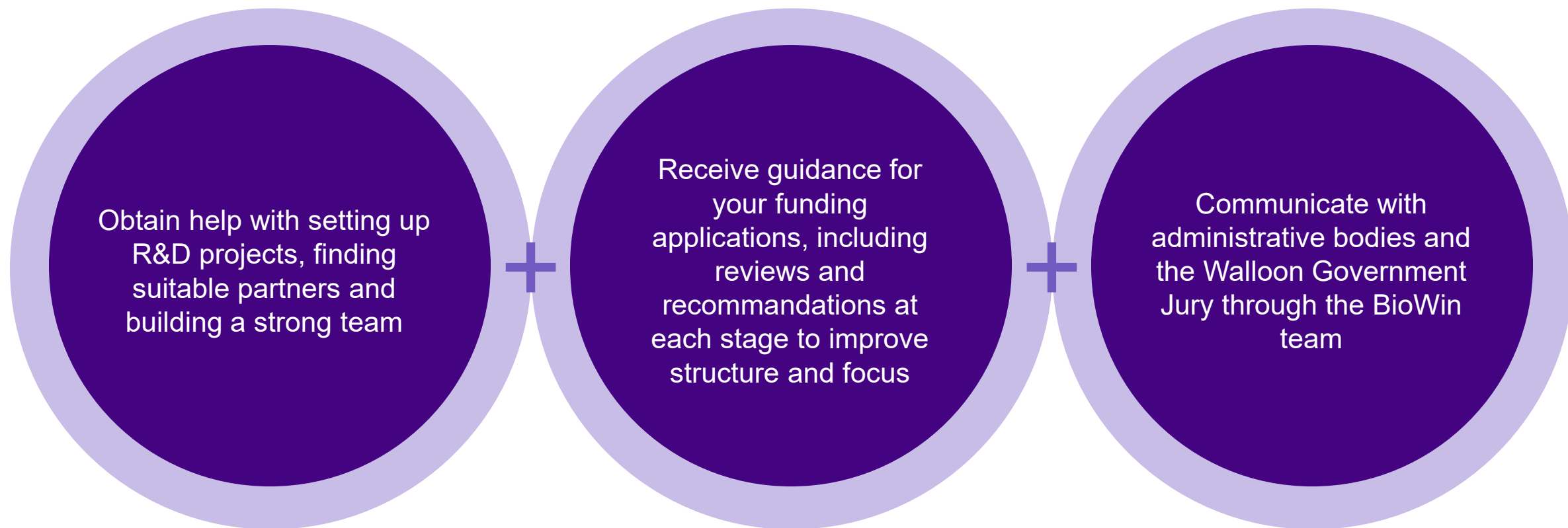

BioWin open calls

Funding eligibility criteria

A strong team

A minimum of four partners (two companies & two research units) collaborating effectively with role distribution based on expertise and complementarity



Financial stability required

Partners must have sound finances and sufficient capital upon final project submission.



Innovate

The project must be innovative, meaning it should develop new or significantly improved products, processes, or technologies. Concrete deliverables must be achieved with a sound valorisation and business plan.



Regional impact

The product, service, or process in development must have meaningful socio-economic impact with regards to the Walloon ecosystem (job creation, added value etc.) and international ambition.

Timeframe and budgetary framework

Two to four year projects with a budget of €1m–€5m

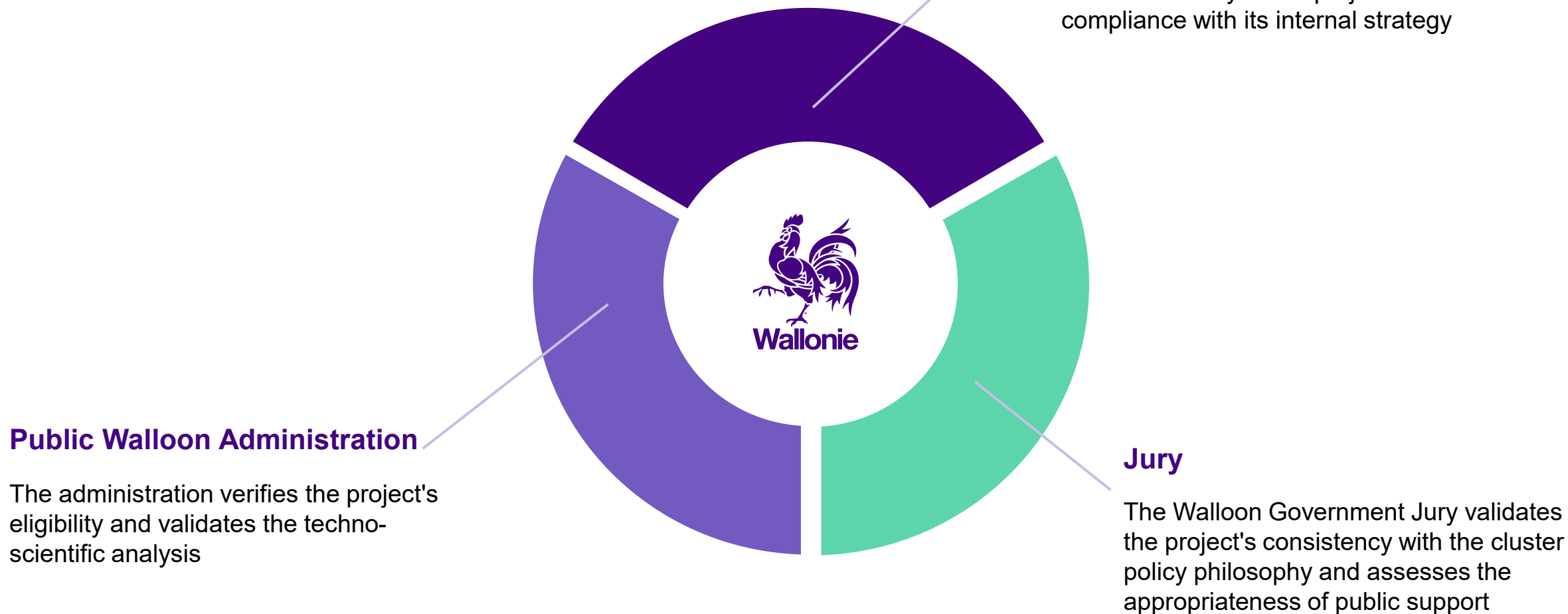
Level of funding support

Organisation	Industrial research	Experimental development
Small company	80%	60%*
Medium company	75%	50%*
Large company	65%	40%*
Accredited research centre	85%	
University, college & public research organisation	100%	

*Each partner company can choose between a grant or a recoverable advance; choosing recoverable advance results in a 10% higher funding rate.

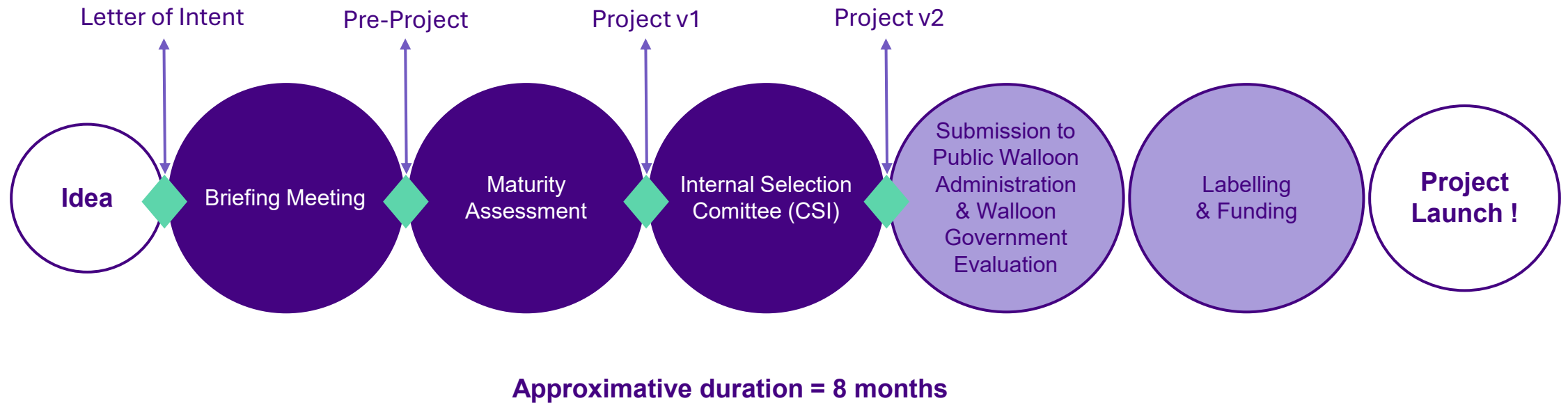

Standard assistance package & fees

Companies must be **members of BioWin** to benefit from open call funding.

Support services follow our standard assistance package, with a double upfront fee:

€1,500 for the first review and recommendations, and **€1,500** for the second review and project evaluation. A **2% success fee*** applies after project labelling.
